For Porch Co PVC Panels

WARRANTY APPLIES TO PORCH COMPANY PVC PANELS ONLY

The Porch Company warrants that their PVC Panels will not rot, spit, splinter, check or suffer structural damage from termite or fungal decay for a period of twelve (12) years. These panels are strictly "Expanded Foam PVC (polyvinyl chloride) sheets."

Purchaser's sole remedy for any claim whatsoever, whether in contract, warranty, tort, or strict liability, arising out of the use, storage or possession of The Porch Company PVC Panels, including without limitation any claim that The Porch Company PVC Panels fail to perform as warranted, shall be replaced. To obtain replacement, the original owner must submit this warranty certificate, with the original purchase invoice indicating the date of purchase, picture of the defective product and detailed description to The Porch Company, 618 Vernon Ave. Nashville, TN 37209.

MANUFACTURER'S LIABILITY UNDER WARRANTY IS LIMITED SOLELY TO REPLACEMENT OF DEFECTIVE PRODUCT.
